VETERAN/DEFENDER/CITIZEN MEMORIAL MEDALLION APPLICATION INSTRUCTIONS

MEDALLION PROOFS MUST MEET THESE REQUIREMENTS FOR EACH TYPE!

Databases and indexes are abstracts of original records and may contain transcription errors.
A copy of the original source record should always be submitted, if available.

Veteran: Documented proof of service preceded and rendered in the Texas Revolutionary War, which spanned from 1821 (when Moses Austin was first given permission to settle 300 families in Texas) to 1836. For example, military incidents occurred in 1826, 1832, and 1835 preceding the decisive movement before the Battle of Gonzales. Also required is primary proof that the individual is the same as represented in record of eligibility. Proofs in foreign languages must be accompanied by translation in English.

Types of proofs may include:

1. Spanish military records
2. Mexican military records
3. Republic of Texas government, military, or land grant records
4. Promissory notes or Scrips
5. newspapers
6. court records
7. DRT/CRT membership ancestor proofs that have already established veteran's service.

Defender: Documented proof of military service rendered for The Republic of Texas between April 23, 1836 and February 19, 1846. Also required is primary proof that the individual is the same as represented in record of eligibility. Proofs in foreign languages must be accompanied by translation in English.

Types of proofs may include:

1. Republic of Texas government, military, or land grant records
2. newspapers
3. court records
4. DRT/CRT membership ancestor proofs that have already established defender's service.

Citizen: Documented proof of place of residence in The Republic of Texas between April 23, 1836 and February 19, 1846. Also required is primary proof that the individual is the same as represented in record of eligibility. Proofs in foreign languages must be accompanied by translation in English.

Types of proofs may include:

1. court record(s)
2. land grants, (including "Toby Scrips;" head rights, first, second, third, and fourth class; preemption grants; land scrips; colony contracts; bounty certificates; and donation certificates)
3. marriage records, if it indicates where performed
4. census records
5. tombstone inscriptions
6. cemetery records
7. newspapers
8. tax records
9. DRT/CRT membership ancestor proofs that have already established citizen's residency.
